2. Open Actions and Business

- **Replication training, workshop (D 5.2- Action closed)** has been organized with the following actions:
- **Replication strategy D 5.1 (M3-Action is in progress):** The first draft prepared by EUROCITIES for input to city leads (also sent to UrbanDNA before the event on 16 March). EUROCITIES presented the strategy and some elements have been discussed. City leads will receive it on 25 March for further update and contribution.
- **Governance- setting up cross-departmental groups and focus groups (M4):** EUROCITIES has facilitated a discussion to support exchange of practices amongst the cities. As several cities have already set up such groups (e.g. Bordeaux, Burgas, Milan) and others taken a different solution (e.g. Greenwich), cities agreed to write down their individual approaches. EUROCITIES facilitates this process and will prepare a template with questions.
- **City baseline report (M 8-Action is in progress):** The report should have at least two parts: 1) broader approach with a holistic vision and strategy; 2) focus on specific measures. The level of detail in the report will depend on the level of interest declared by the given city on the given measure. Later, should be a **“Mapping Measures Matrix”** prepared by each city. Some cities (Burgas, Warsaw, Milan) have good experience with EUROCITIES on other projects and they will test, engage more actively with ideas how these reports should be developed both in terms of structure and content. Other cities are also welcome to contribute. The draft template and first contents will be prepared by

beginning of May in order to allow updates and related planning. Also KPIs will be identified relying on existing input (e.g. such as CityKEYS; it has been also agreed that Bordeaux can provide further input there).

- **Mapping Measures in Matrix** (e.g. e-Mobility) should be prepared. In each city should be first this studied, as there is still a lot of uncertainty around which specific themes should be covered by city cooperation: Lisbon together with EUROCIITIES and UrbanDNA will draft/test together a structure and content for a first template which they will propose to all cities to be filled out. The WP3 closely related to this activity therefore also partners from there will contribute. The purpose is to get more clarity on which city is interested in developing which measure more particularly and to what extent (this allows also to identify on which areas and which cities should focus on during their **work-shadowing visits** and how those should be later organized). This work should be therefore ready by early May in order to plan the work-shadowing visits.
- **Work-shadowing visits:** It has not been definitively decided which cities (1 `fellow` and 2 `lighthouse`) would work more closely together as it depends on the areas/measures to be covered. Initial trio cities are: Bordeaux: London, Lisbon; Burgas: Lisbon, Milan; Warsaw: London, Milan. Nevertheless, the preparation process of the baseline reports and setting up the working groups should give enough clarity by the latest beginning of May on the exact cooperation and visits. It might be an idea to held combined visits where 2 fellow city visits a lighthouse city at the same time. EUROCIITIES will support the planning of these visits with guidance.
